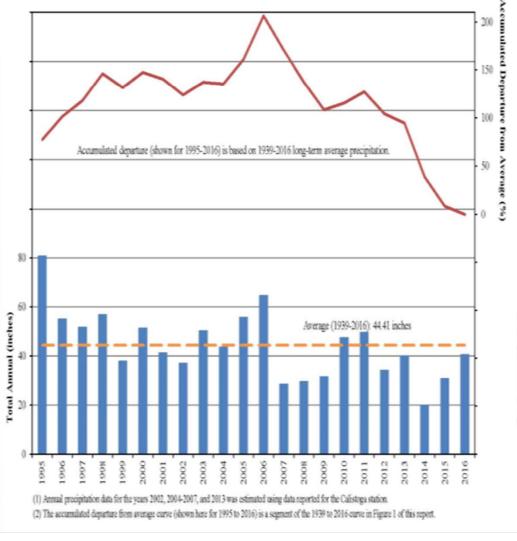

"...the term that mandates supplemental stream flow releases, and the term that requires the District to implement the 1997 groundwater monitoring plan, were incorporated [into our license and permit] in the event that the District's water diversions did in fact adversely impact subsurface accretions.

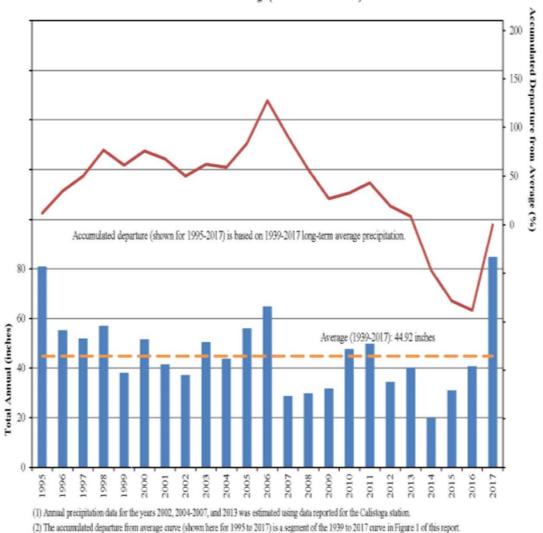
"Groundwater elevation data compiled by the District and others since 1997, as well as riparian habitat surveys conducted on behalf of the District from 2007 through 2014, indicate that there has been **no measurable impact** to subsurface accretions or degradation of riparian vegetation as a result of the District's water diversions. Additionally, more abundant and dense riparian vegetation was found to be present during recent surveys of Putah Creek **upstream** of the supplemental discharge location compared with the area downstream of the gage, even though supplemental discharges have been released to downstream areas during the summer months almost every year since 1995."

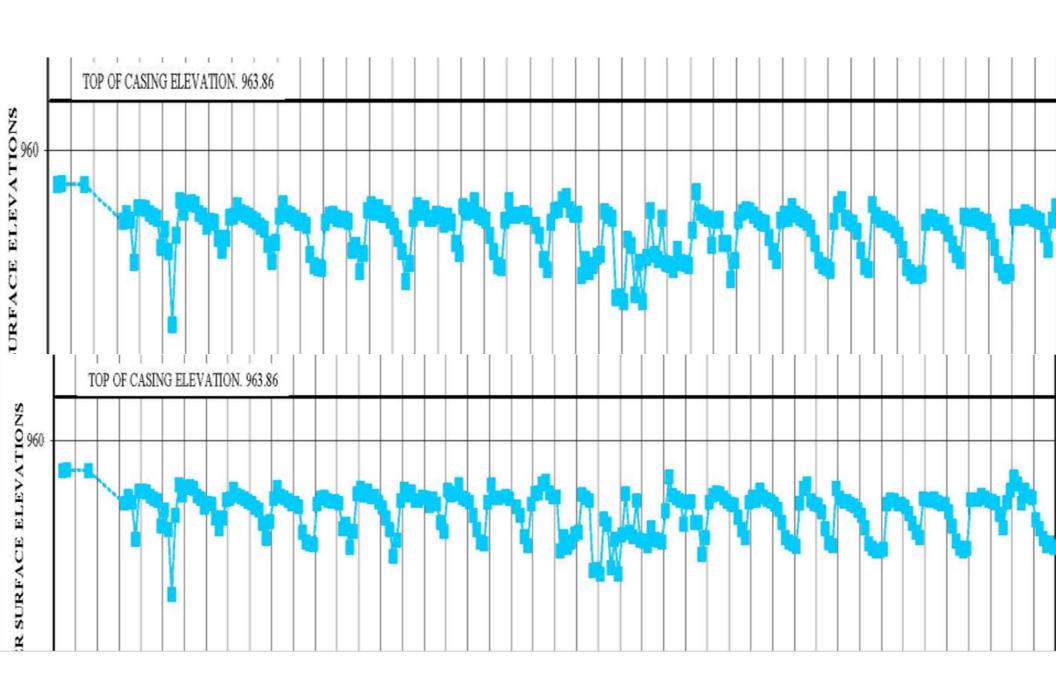
"The average annual use per connection has decreased by more than 25% over the past decade (2017 use compared to 2007 use) due to the District's aggressive water conservation program."

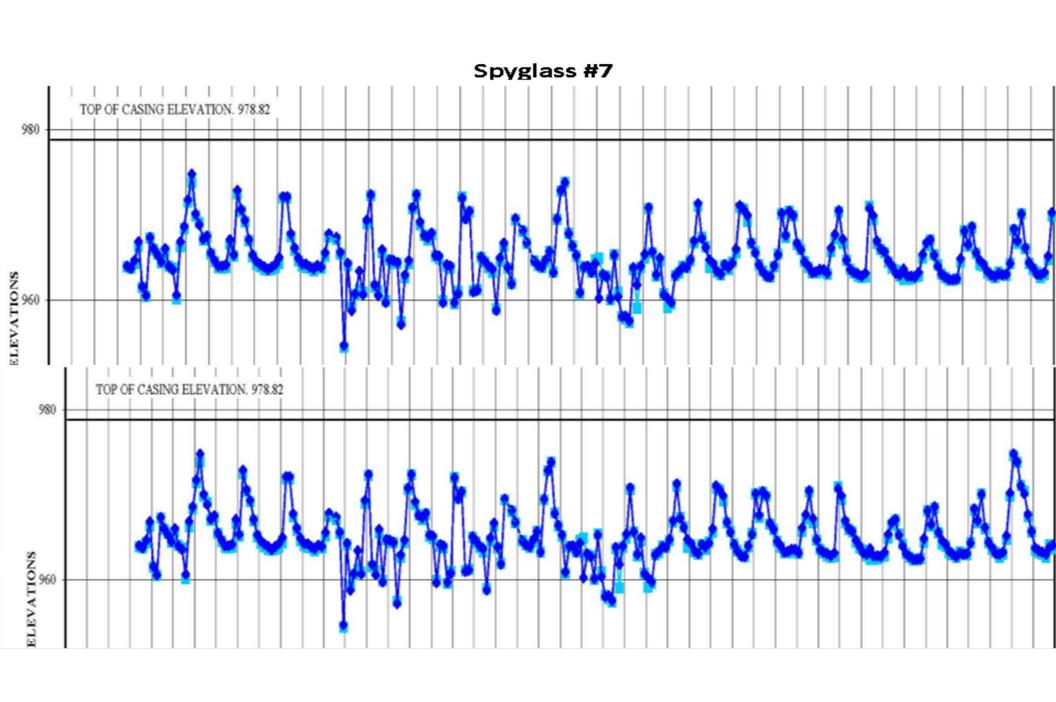
Middletown Precipitation

1939-2016 Average (Shown for 1995-2016)

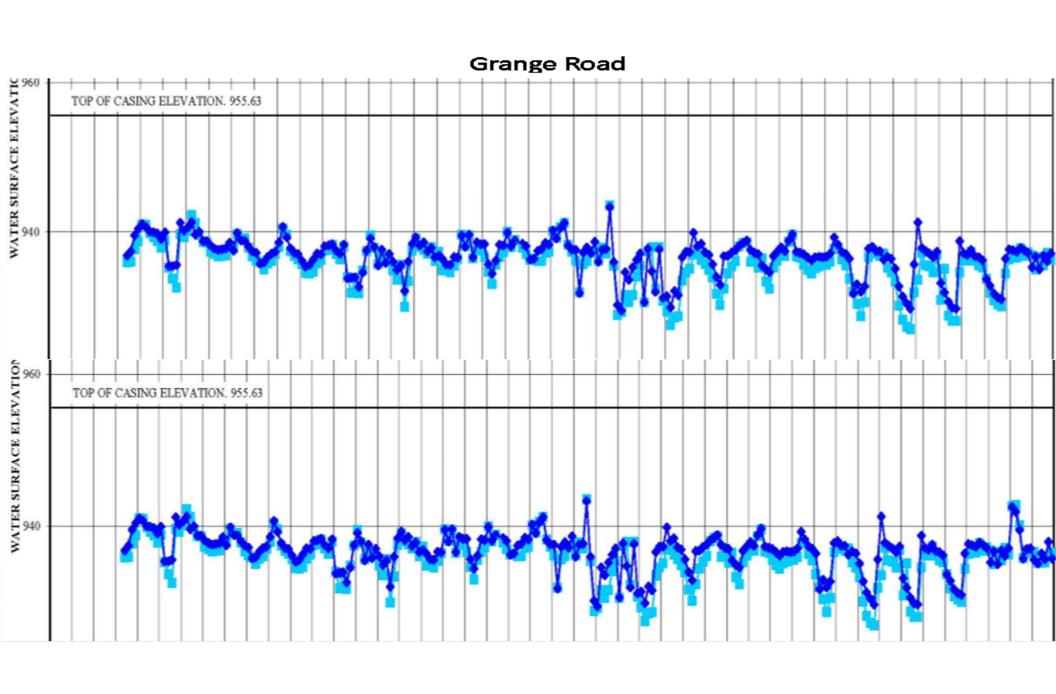


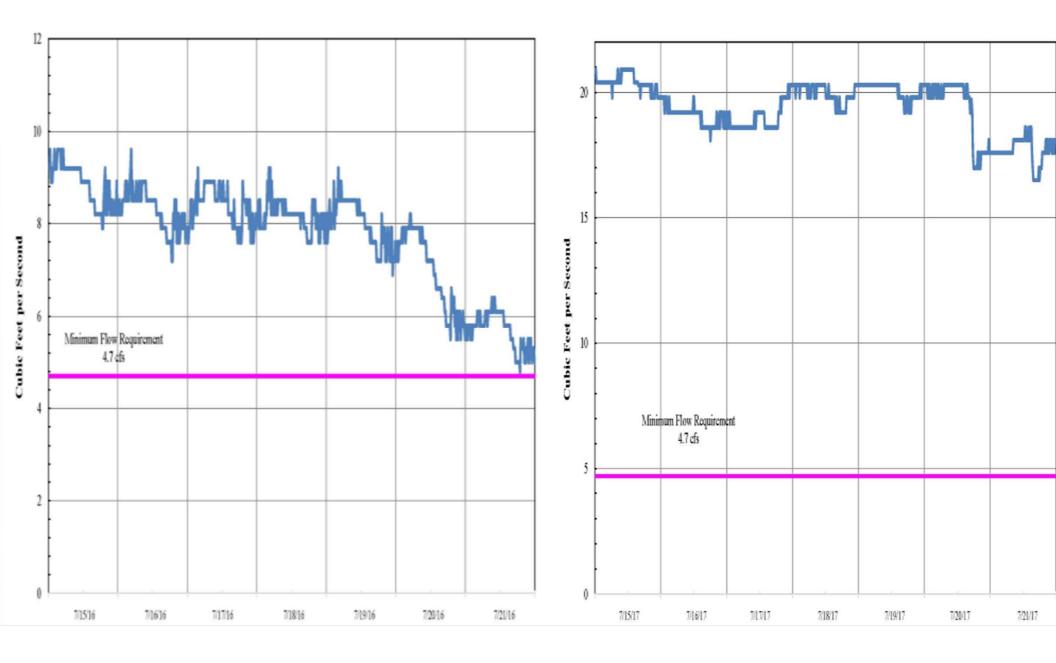
Middletown Precipitation Total Annual and Accumulated Departure from Average 1939-2017 Average (Shown for 1995-2017)

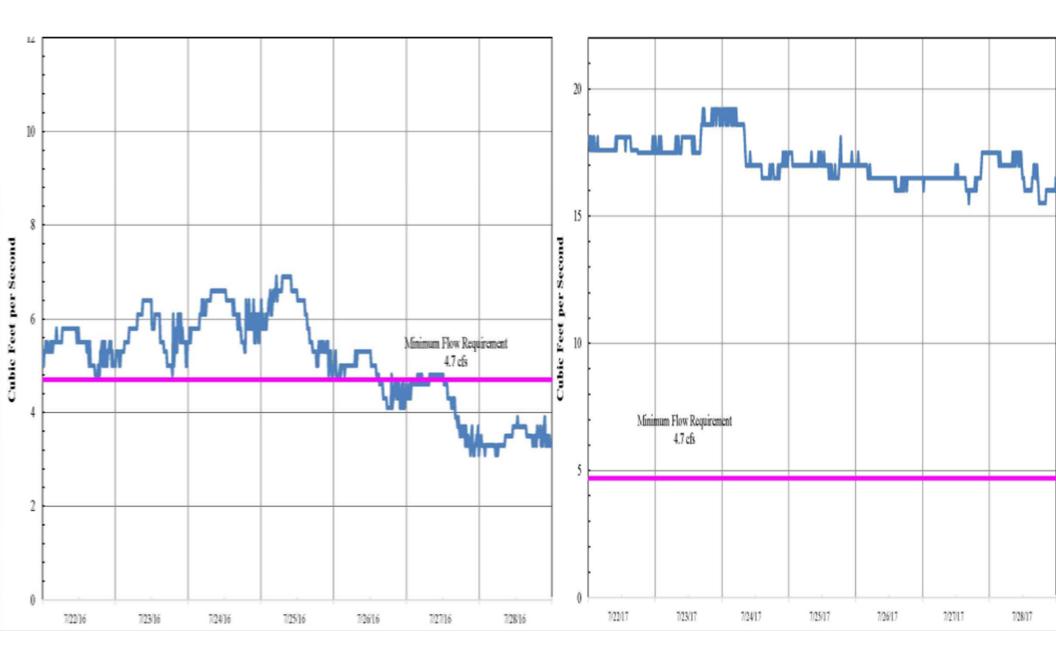


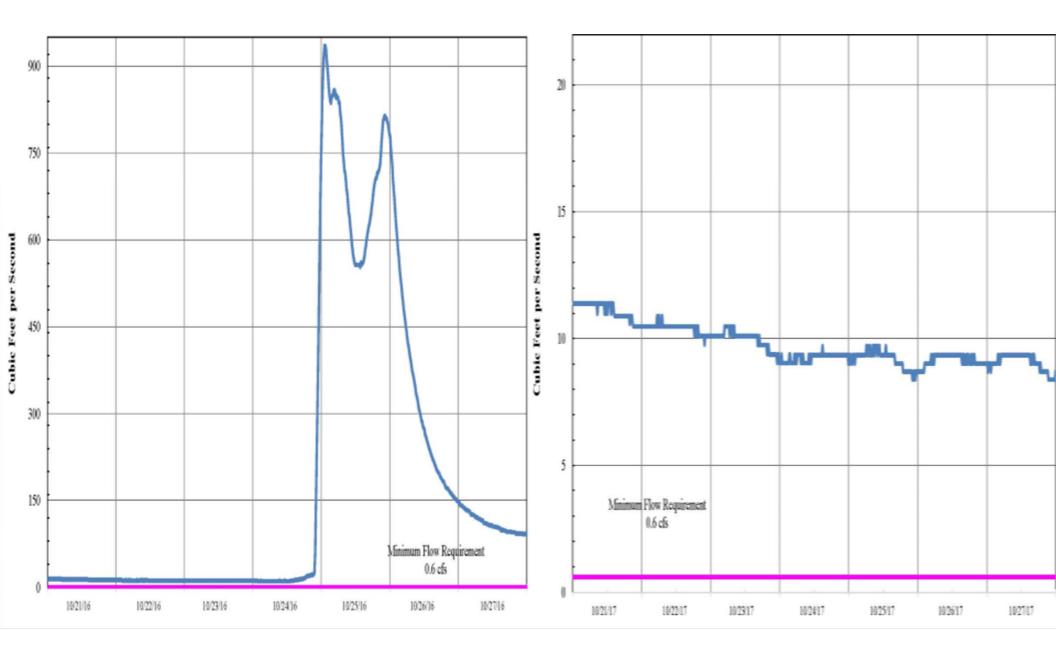


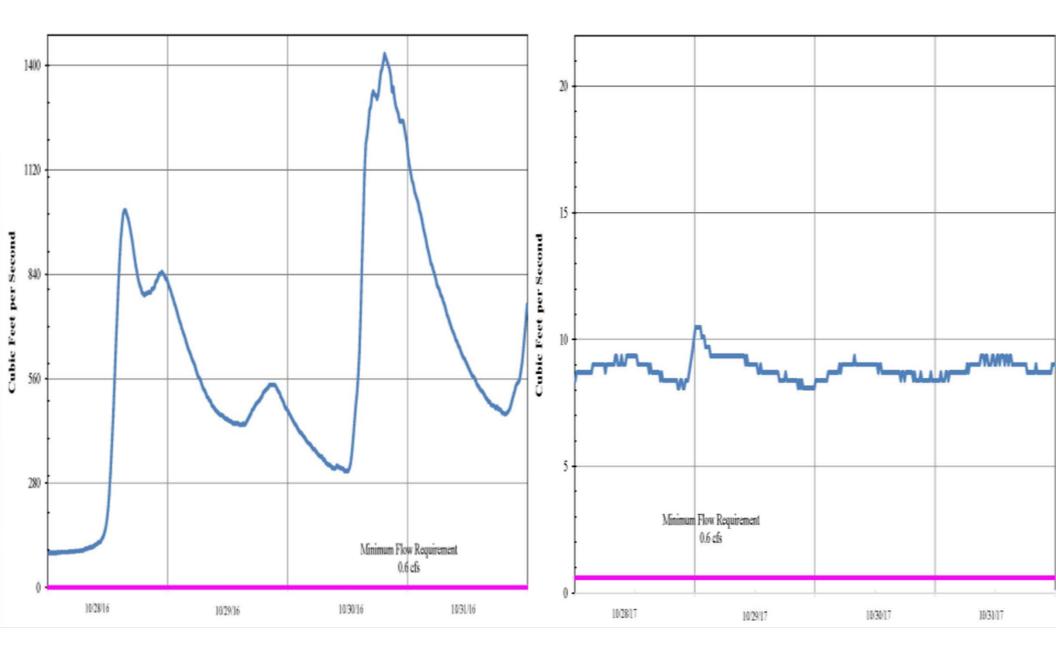

Project Over-View

Currently the project is pending County approval; therefore, no definite timeline of the project can be provided at this time.

The District plans to work with Mr. Porter in the development and design of the Valley Oaks water, wastewater and recycled infrastructure. The Developer will be responsible for all cost of the project.

Short Term: Annexation Process and The Two Ways to Approach It

The Committee agreed the best short-term approach would be for the District to begin the annexation process with LAFCO. The complete process is expected to take a minimum of 6-9 months. Mr. Porter will provide the District with an electronic copy of the property survey.

Long Term: Water, Sewer & Recycled Infrastructure Requirements

General Manager, Kirk Cloyd provided an overview of the water, wastewater and recycled water infrastructure requirements that Valley Oaks Project Developers must meet.

A quote will be requested from Coastland for the preliminary design of the infrastructure. Mr. Porter will provide the District the water and sewer capacity demand report.

Dear Chair Wieckowski and Chair Bloom,

I am writing to express our strong opposition to a proposed state tax on drinking water before the California Legislature. The proposal is being advanced through SB 623 by Sen. William Monning (D-Carmel), a two-year bill introduced in 2017, and a Brown Administration budget trailer bill that is based on SB 623. As a local water agency, we are committed to delivering safe and reliable water. We wholeheartedly support the goal of ensuring safe drinking water for all Californians, especially those in disadvantaged communities. However, taxing Californians for something that is essential to life does not make sense, especially at a time when some are raising concerns about the cost of living in the state. Our agency has serious concerns with requiring California's local water agencies to collect this tax for the state. Simply put, taxing drinking water — an essential life-sustaining resource — is just not sound policy.

As an alternative, we are working to advance a more appropriate package of funding, which would include existing federal funds from the Safe Drinking Water State Revolving Fund (SRF), voter-approved general obligation bonds, the assessments related to nitrates in groundwater proposed in the budget trailer bill and in SB 623, and a limited amount of general fund dollars.

For these reasons, Hidden Valley Lake Community Services District opposes the budget trailer bill related to a tax on drinking water and SB 623 and respectfully requests your "NO" vote on these measures.

RE: General Manager's Monthly Report

Good evening, the following report discusses items Hidden Valley Lake CSD completed over the past month. This report is intended to provide the Board and public with an update on the progression of projects and current status of relevant issues.

Water

- 1. Moratorium update: As previously noted, our Regional Water Quality Control Board's work load increased exponentially with the North Bay fires and the meter moratorium issue was transferred to the State Water Resources Control Board-Region II Program Chief, Stefan Cajina, who forwarded it to Ms. Jule Rizzardo, Assistant Deputy Director of the Water Rights, Permitting & Enforcement Branch at the State Water Board. Both staff and several constituents have left messages for Ms. Rizzardo, however, Ms. Rizzardo has failed to return any calls. On Feb. 8th Senator McGuire's office sent a letter directly to Felicia Marcus, Chair of the CA State Water Resources Control Board requesting they consider lifting of the meter moratorium.
- 2. Staff submitted the Annual Groundwater Monitoring Report to the state.
- 3. Staff attended a Webinar entitled: WaterSide Chat: Avoiding AMI Deployment Surprises

Sanitary Sewer

- 1. Lake County has made repairs to the water crossing damaged during the Valley Fire recovery efforts and had the RWRF access road graded. The road is much better than before but additional fill, shaping and compaction will be needed followed by 4" of asphalt to ensure access during and after rain events.
- 2. The General Manager completed Sewer Use Ord. 59.1 to replace Ord. 48. Staff has reviewed the draft Ordinance and it is expected to be brought to the March Board meeting for the required Board and Public comment period.
- Staff has developed Recycled Water Best Management Practices (BMP's). It is
 expected that a resolution will be brought to the Board for adoption of the BMP's in a
 future Board meeting.
- 4. Inspected the chemical storage and containment at the HVLA pool. HVLA was notified of the Federal 40CFR 405 requirement to contain the specific chemicals they

use, making sure they can not spill or drain to the sewer system. HVLA placed a berm around the flood drain in the chemical storage and mechanical room to achieve this. A follow up inspection is needed to close HVLCSD's report.

Stormwater

Nothing to report.

Human Resources

- 1. A meeting with the Personnel Committee took place to discuss the draft Employee Handbook. It was determined that the document would need major revision and that a rewrite should be considered. Staff has since forwarded a copy of SDRMA's Employee Handbook as well as an employee Memorandum of Understanding (MOU) for consideration. Since SDRMA is a risk management agency, their employee handbook may not relate to our utility staff as well as an employee MOU from a utility agency.
- 2. CPS HR Consulting has addressed a number of staff and District concerns related to the salary survey. The Personnel Committee has noted that the comparables are appropriate. Once the numeric values have been reviewed by the Finance Committee and any of their concerns addressed, the final report will be brought to the entire Board for review and possible acceptance.

Facilities

The General Manager renewed the annual contract with the Konocti Conservation Crew #27 for weed abatement and debris removal at a substantial cost savings over previous weed abatement methods.

Vehicles & Equipment

General Information

- The Konocti Conservation Crew #27 continued to drop trees damaged by the Valley Fire, on the Dallas Ct. property. They made use of the District's burn permit conducting control burns of the small debris.
- 2. Verizon Tower Update: The General Manager contacted the Verizon representative for the proposed cell tower at Little Peak Water Tank. Because AT&T submitted their proposed tower on the Wild Diamond Vineyard property ahead of Verizon, Lake County Planning Commission has directed Verizon to evaluate that site for service. If Verizon can provide the same quality of service from the proposed AT&T cell

tower, the Lake County Planning Commission will require Verizon to install their equipment on the AT&T tower and not build the Verizon tower on District property.

- Staff is developing a Fee Schedule to replace Ordinances 56 (Water Rates) and 58 (Sewer rates) to be approved by Resolution. It is expected to be brought to the April Board meeting.
- 4. Staff is working with LAFCO and coordinating with Valley Oaks representatives to begin the annexation of the valley Oaks property into the District boundaries.
- 5. Staff submitted the five required Notice of Interests (NOI's) to FEMA/CalOES for the Haz. Mit. projects we have listed in Lake County's Local Haz. Mit. Plan. HVLCSD received notification that we can submit funding requests for four of the projects which include:
 - A. Replacement of the five wooden water tanks.
 (\$7.596M project of which the District obligation is \$1.899M. Additional Federal funding may be available.)
 - B. A new well (Cr6 & meter moratorium & security buildings over the three existing wells and chlorination facility.)
 (\$3.774M project of which the District obligation is \$0.9435M.)
 - C. Replacement of the Stormwater swing check valve with a Tideflex valve. (\$0.634M project of which the District obligation is \$0.1585M.)
 - D. Emergency generators for all potable water facilities. (\$2.712M project of which the District obligation is \$0.678M.)
- 6. The G.M. attended the following classes at the Urban Water Institute Conference:
 - A. Climate Change & Its Impact On Water
 - B. What Is The Future Of Dams In California

- 8. Staff reviewed the Lien policy and conferred with legal counsel as it is believed that Lake County is charging HVLCSD for part of the process that we are exempt from. This will be brought to the County's attention.

9. HVLCSD received another obligatory letter from FEMA/CalOES for the 2017 flood in the amount of \$235K. Approx. \$117K will be paid to Lake County Special Districts for treatment of wastewater during the flood period.

AGENDA ITEM: Discussion and Possible Approval: Adoption of Resolution 2018-01 authorizing HVLCSD to enter into a financial assistance agreement with the USBR, and designating a representative to execute the

agreement.

RECOMMENDATIONS: Adopt Resolution 2018-01.

FINANCIAL IMPACT:

At a maximum award of \$750,000 per project, the (USBR) Bay-Delta Restoration program would provide 50% of the total cost of a project, and the applicant would be responsible for the remaining 50%. This new Federal (USBR) grant program is in line with the water efficiencies gained by the AMI project.

Since the AMI project has already been vetted, the total cost of this project has been calculated to be \$1.6M. A State Revolving Fund (SRF) loan application has been submitted for \$818,000. This \$818,000 loan is HVLCSD's matching funds obligation in the state grant program.

If awarded grant funding through the USBR, the financial impact to this grant application and approval process is to reduce HVLCSD's SRF principal from \$818,000 to as low as \$68,000.

Consequently, HVLCSD's time to reach a Return On Investment (ROI) is greatly reduced.

BACKGROUND: The Bureau of Reclamation (Reclamation) is a participating agency in the Bay- Delta Restoration Program. The Bay-Delta Restoration Program includes strategies to address ecosystem health, water supply reliability and water quality. Water use efficiency is a critical element in the successful implementation of the Bay-Delta Restoration Program.

Reclamation has posted a Funding Opportunity Announcement (FOA) for cost share funding for water use efficiency and conservation activities. Up to \$3.0 million in Federal funds will be available for awards up to \$750,000 per project. No more than \$750,000 per project, and \$1.5M per recipient, will be awarded under this FOA. Estimated number of agreements to be awarded: 3-10.

Applicants must be able to cost share at least fifty percent (50%) or more of the total project costs. Cost sharing may be made through cash or in-kind contributions from the applicant or third-party partners. Cost-share funding from sources outside the applicant's organization, e.g., loans or state grants, should be secured and available to the applicant prior to award.

Application Due Date: March 15, 2018 1:00 PM PST.

It is predicted that funds may be awarded no later than September 19, 2018, contingent on appropriations.
